### WIAW

Thanks to members of the Candlewood Amateur Radio Association (CARA) for operating W1AW in this past weekend's New England QSO Party (NEQP). They made 381 QSOs on 20 meters using CW and SSB.

Scott worked on slow and fast code practice texts for the upcoming week. He also processed 6 electronic VUCC and 2 paper VUCC applications, and processed 611 VUCC credits between the two. # <u>IT</u>

### **Experimentation**

Zack designed a dual band collinear for 12 and 15 meters. It uses both traps and section of window line. It has 3.2 dBi of gain in free space, 1 dB more than a dipole. Zack plans to put one up at his house, pointed toward Europe, so all of his dipoles will be aimed that way on 40, 30, 20, 17, 15, 12, and 10 meters.

### Product Review

Bob Allison tested a small, five band, QRP transceiver. Testing was halted, once it was found to have a keying waveform with nearly zero rise and fall time, causing bad key-clicks to be transmitted. Bob contacted the manufacturer to share the test results. They are currently working on a fix. Bob then started testing of a dual band handheld transceiver.

Bob also took part in a Product Review video featuring a spectrum analyzer as the reviewed item. While setting up for the video shoot in the Lab's screen room, Bob discovered that this compact, low priced spectrum analyzer has the ability to measure conducted emission levels (used with the appropriate Line Impedance Stabilization Network). This feature is very useful for measuring the unintentionally generated noise from consumer devices, such as switch-mode power supplies and grow lamps. As part of the review process, this analyzer was calibrated at Essco laboratories, in Chelmsford, MA. With a fresh calibration sticker on it, the analyzer is ready to serve our membership!

### Radio Frequency Interference

Mike Gruber received a response to a letter that he had sent to SolarEdge concerning RFI issues from their systems. In the letter, SolarEdge indicated that they do not recommend installing their equipment near a ham station(!) At the moment, there are four active complaints involving SolarEdge equipment. The primary source of RFI problems involving PV systems seems to be SolarEdge "optimizers."

Mike attended Tony Brock-Fisher's, K1KP presentation at NEARfest on Friday. Tony is the author of a QST Article involving RFI remediation from his SolarEdge PV system. Tony indicated that he has helped a number of hams since that article was published and will be happy to show Mike his system and help take some filed strength measurements, probably in June. Tony will also be at the Dayton Hamvention.

# Technical Information Service.

Jeff, W2JEB, called Zack Lau to say he was having trouble finding the latest STB80F03L used in the May, 2017 QST over-voltage protection project. Mouser's web page suggested it had 410 in stock, but for some reason they weren't available for order. Zack suggested he call Mouser. Zack also found that Mouser had a large quantity of the older STP80NF03L that could be used with a slightly higher voltage drop that wouldn't matter for most amateur applications.

# **Volunteers**

This was a busy week for the Lab's volunteers. Mike Marinaro, WN1M and Jonathan Allen, K2KKH, met with Bob Allison to discuss future plans for the ARRL Heritage Museum. Additional written material will soon be added to the museum's web page. A solid plan was made for the thinning out and cleaning of the ARRL Library. Volunteers Ray Thornton, W1YFF, Lori Kosior, N1SMK and Pete Turbide, W1PT all worked on equipment that was recently donated to the ARRL.

Volunteers from the Vintage Radio and Communications Museum of CT were also on hand, working on the Gates BC-1T transmitter (see photos below). This work is spearheaded by Dan Thomas, NC1J, who is a former radio and television broadcaster, spending his career in front of the mic/camera and inside of a broadcast transmitter. Please stop by the Lab on Tuesday mornings and say "hello' to Dan. The Gates transmitter will be ready for test transmissions by the end of this month.

#### **Regulatory Affairs/Secretary**

Lots has been going on during the last couple of months keeping the Regulatory Information /Assistant Secretary quite busy. As we approach the busy summer travel months, we are receiving a steady stream of requests for information about reciprocal operating. Several items on the ARRL webpage about reciprocal operating have been reviewed and updated. The most common question is from visitors to the US wanting to know how to obtain a US callsign. Most are let down when we explain that while we have reciprocity with many countries that permits them to operate during their visit to the US, the only way to obtain a US callsign is to pass the US License exams. We also explain that once they obtain a US license of any kind, they are no longer eligible to operate under the privileges they have under reciprocity.

We continue to work actively with the Official Observer modernization working group, chaired by Vice-President Mileshosky. As part of those efforts, we have taken the lead in the re-write of the training manual for OOs. In addition, we recently had the opportunity to have a face-to-face meeting with Laura Smith at the FCC, where we discussed several action items the group is considering. We also had an opportunity to meet with former FCC Special Counsel Riley Hollingsworth, who is participating in the discussions at the invitation of Vice-President Mileshosky, who has been very helpful in highlighting several issues for the group to consider in its deliberations.

The various state legislatures are still actively in session, and to date over 2,000 bills that have been introduced have been reviewed. Fortunately, most the bills that are "tagged" by our service for review (using key words such as "tower" or "restrictive covenants" among others) have no connection to the Amateur Radio service. We also continue to receive calls every week inquiring on the status of HR 555 – The Amateur Radio Parity Act. We explain that while there is no fresh news to report, our DC team continues to work diligently on the matter – that it is a continued ongoing concern for the ARRL. A RallyCongress letter for Oklahoma Senator Inhofe was recently prepped and distributed, thanking him for his efforts on addressing problems for Amateurs with last year's legislation on tower marking and painting for short towers.

Preparations are in place for the counting of ballots for the SW Division Vice-Director election, which will take place on Friday May 19<sup>th</sup>. We have worked with Elections and Ethics Chairman Tom Frenaye to get the team in place for opening and counting ballots at ARRL Headquarters that afternoon. Many thanks to ARRL HQ staff and managers for their cooperation with staffing the project for that afternoon. We are also involved with the preparations for the July Committee and Board meetings.

As a member of the Awards Committee, we have been involved in multiple discussions over the DXCC status of the Midway and Kure entities. Though no longer running Field Day, we have touched base several times with ARRL Contest Manager Bart Jahnke on various aspects of preparations for the event.

### **Sales and Marketing**

Many items were completed to finalize planning for ARRL EXPO at Hamvention. We accommodated a handful of last minute requests for hotel rooms and additional volunteers. Steve Capodicasa reports that our shipment for ARRL's exhibits arrived in Ohio; 10 pallets - 6,500 lbs.

ARRL earned \$4,644 in March, and \$2,850 in April for royalties attributed to the ARRL Visa Credit Card. The largest source of program growth is email conducted by ARRL on behalf of U. S. Bank. YTD (Jan-Apr), ARRL has earned \$13,872 (\$13,103 in 2016). There are 2,677 open cards. Card holder sales volume was over \$2.4 million YTD. ARRL earns royalties on newly opened cards and on net purchases. U.S. Bank will have representatives in the ARRL exhibit area during Hamvention. The bank included special messaging on its card holder statements in April/May, encouraging customers to visit the ARRL exhibit area, and offering incentives for using their cards while in Ohio during the convention.

Jackie Ferreira reports that we are now shipping a new black mug for the ARRL Collegiate Amateur Radio Initiative, which includes the program logo and slogan "We Want U."

Yvette Vinci reports that in May we processed 34 paid-in-full Life Memberships and 14 Life Membership pledges.
