Chief Executive Office

Much of last week was spent adjusting to rapidly changing information and circumstances at HQ due to the Covid-19 global pandemic. Many conventions had already been cancelled the week before, and just about all of the remaining events scheduled through the end of April were cancelled by mid-week. Barry Shelley, N1VXY, and Diane Middleton, W2DLM, asked HQ managers to identify what tasks could be done by their staff remotely, and how operations may or may not be affected. By Thursday, as more shelterin-place edicts were issued around the country, Barry and Diane began coordinating with Michael

Keane, K1MK, Dave DiStefano, KB1DAD, and the rest of the IT staff to prepare as many staffers to work from home as possible should the governor of CT make the same decision.

As expected, that executive order was in fact announced by Governor Lamont last Friday, declaring that all non-essential businesses state-wide close doors by 8pm on Monday, March 23, and allow workers to work from home wherever possible. Fortunately, over ¾ of HQ's staff have been able to make the adjustment to working remotely and are still serving the membership and meeting production deadlines, though the evolving situation continues to be closely monitored by Officers and Board members. Barry, Diane, IT staff and many managers reported to HQ on Monday to finalize all the details needed to enable remaining staff to work remotely and to close the office that evening. The governor's announcement stated that CT should expect this order to last through April 22. Product Development

Kris Bickell, K1BIC, and Bob Inderbitzen are working together to develop ways to recruit experienced member volunteers to give remote presentations as regular offerings. Our initial cut at this planning may enlist assistance from Field Organization volunteers, including Section Managers, to help us identify subject matter experts from across the variety of amateur radio interests and topics. We teleconferenced with Idaho SM Dan Marler, K7REX, who runs a weekly web conference for the Section Managers, to seek some feedback and more ideas.

Bob has engaged Ed Hare, W1RFI, for the Lab's assistance as we refine the design specifications for ARRL's basic build-a-radio kit offering. Bob continues to work with two student engineers from Florida on the project. Kris Bickell is closely following this planning for opportunities to keep this project aligned with our learning initiatives.

A handful of administrative tasks were completed in the wake of Hamvention's decision to cancel their 2020 event, e.g., informing member volunteers and many other stakeholders, cancelling travel reservations, etc.

Bob created a <u>video</u> using some footage he shot in 2018 to help support a post on ARRL's Facebook page featuring March *QST*'s member spotlight on Ed Finnegan, K9ECF. The video includes an interview conducted by Central Division Director Kermit Carlson, W9XA, at EAA AirVenture. Bob also produced a <u>short article</u>, picked up for ARRL News, summarizing one college radio club's effort to keep connected on-air amid the current social distancing measures.

Bob also provided additional support for colleagues as preparations were made anticipating a decision to work-from-home.


