#### **Development**

June was a busy month for Maxim Society. We are pleased to welcome Walter Sepaniac, N5TQ, of the West Gulf Division, Anthony Perales, AI1U, of the Southeastern Division and Lee Zalaznik, KI6OY, of the Pacific Division as the 288<sup>th</sup>, 289<sup>th</sup> and 290<sup>th</sup> members of the Maxim Society. We are also pleased to welcome Paul Sergi, NO8D, of the Great Lakes Division into the Century Class of the Maxim Society.

ARRL has received a \$10,000 gift through a member's IRA. This contribution is designated toward Spectrum Defense.

#### Lab

Most of the ARRL Lab Staff continues to work at home, servicing our members via telephone and email. Bob Allison returned to the lab to work on *QST* Product Review testing, June 29<sup>th</sup>.

Paul Cianciolo, W1VLF, reports from Harwinton that he has been very busy, with 11 new RFI cases, five of which have been referred by the FCC. Paul wishes to thank to Zak Lau, W1VT, for taking some of the

TIS calls normally handled by him, as he worked on drafting a rather lengthy Electromagnetic Compatibility Committee report to the board for their July meeting. Paul reports the two biggest noisemakers of the week were power line noise and solar power system noise. There are many companies now invested in producing solar power products; all have their own RFI characteristics, adding more challenges to the HF spectrum.

On a personal note, Paul's recent antenna project atop his 125-foot tower did not go well, with damaged

coax and bent elements everywhere. Another attempt will be made on the 18<sup>th</sup>, when a 150-foot crane arrives on site. Let's all hope Paul's project goes well. If it does, Paul promises to share photos here in, "Weekly Report".

Bob Allison is pleased to report from the ARRL Laboratory that he has returned to the laboratory on a limited basis, for testing purposes only. Bob got right to work, completing testing of a high-performance HF/6m transceiver. Soon afterwards, Bob delivered the transceiver to Joel Hallas, WiZR, in Westport, CT, for review.



Bob also tested an inexpensive, dual band, handheld transceiver and has started testing of a solid state, high-performance HF/6m power amplifier.

Bob Allison received a nice donation for the ARRL, from Judith Baldwin, daughter of former ARRL CEO, Dick Baldwin, W1RU (SK). Judith donated 80 stick pins her father had collected while attending various Amateur Radio conventions over the years. Also included in the donation were key fobs, buttons and two of Dick's "W1IKE" (his former call sign) QSL cards, both of which were autographed in 1952, by General Dwight D Eisenhower. An inventory was taken by Bob and a letter of acknowledgement was composed and sent to Judith Baldwin by Maty Weinberg, with gratitude. The collection will make a fine display in the future.

Bob also wishes to report that ARRL Heritage Museum volunteer curator, Jonathan Allen, K2KKH, has resigned his volunteer job and moved to Arizona. The lab thanks Jonathan for his seven years of volunteer service to the ARRL Laboratory and for his dedication to the preservation of the ARRL Historical Collections.

At home, Bob Allison is pleased to report that a brand new NVIS dipole, cut for the 80-meter band, is working quite well, both for very short skywave signals and for regional communications. Bob tested it on Field Day, a good time to use a new antenna to see how well and in which directions it works. Bob reports it works equally well in all directions. The signal goes up, then down again. Fifteen miles via skywave does not sound like much, but it's the only way to drop a signal into one of Bob's friends as local topography prohibits any other signal path other than through repeaters. At night, Bob worked the UK with a 59 + 10 dB signal received at that end, using this dipole, so it's good for some DX.

Zak Lau reports from Newington that calls and email for technical help continue to be received by the laboratory staff. Zak receives the most difficult questions possible; all TIS questions are answered in a very timely manner by the lab staff. Zak reports that during off-hours, he worked former COO, Harold Cramer, WJ1B, on 6 meters. Harold passes his best wishes to the ARRL staff.

#### W1AW

Joe Carcia created the texts for the next week's W1AW Qualifying Runs. He also updated the Qualifying Run schedule and *QST* code practice source web pages. Joe processed five Qualifying Run certificates and five endorsements.

Joe processed regular QSL card requests and performed a quick swap on the 2-meter broadcast amplifier power supply. He also performed a firmware update to the Yaesu FTdx101MP Product Review unit. Joe also made a quick fix to the 80/40-meter fan dipole located in front of HQ.
