Section Manager election ballots were counted on Tuesday, August 21, at ARRL Headquarters with the assistance of Leona Adams, Deborah Voight, and Steve Ewald. In North Dakota, incumbent Section Manager Nancy Yoshida, KG0YL, was re-elected. In Western New York, incumbent Laura Mueller, N2LJM, was re-elected. Their new terms of office begin on October 1.

The following incumbent Section Managers will begin new two-year terms of office in October since they were the only nominees in their respective sections: Chuck Motes, K1DFS (Connecticut); Skip Jackson, KS0J (Minnesota); Scott Yonally, N8SY (Ohio); Kevin O'Dell, N0IRW (Oklahoma); Oscar Resto, KP4RF (Puerto Rico); Fred Kleber, K9VV (Virgin Islands).

In Eastern Pennsylvania, George Miller, W3GWM, of Wyalusing, will become the new Section Manager on October 1 for an 18-month term of office. Miller, who has been the Section Traffic Manager, was the only nominee when a re-solicitation of nominations took place this past spring. Bob Wiseman, WB3W, who has been the Eastern Pennsylvania Section Manager since October of 2016, decided not to run for a new term of office. He has however continued serving as SM for an extra six months after his regular term concluded at the end of March.

The Southern Florida Section will welcome Barry Porter, KB1PA, as its new Section Manager on October 1. Porter, of Delray Beach, has been an Assistant Section Manager, Assistant Section Emergency Coordinator and Emergency Coordinator. He was the only nominee for the position after Jeff Beals, WA4AW, announced that he would not be seeking a new term of office. Beals has been Section Manager since 2014.

Western Pennsylvania Section Manager Joe Shupienis, W3BC, has been nominated to run for a new term of office that begins on January 1, 2019. Nominations for this particular Section Manager election cycle are due at Headquarters by September 7.

REPORT FOR WEEK ENDING SEPTEMBER 25:

Expense and revenue schedules were completed for 2019/2020 planning.

Jackie Ferreira and Bob Inderbitzen worked with convention committee members to help prepare an announcement supporting the upcoming Pacific Division Convention, Pacificon, which will be held Oct

19-21 in San Ramon, California. Jackie also completed a handful of email solicitations and other direct mail projects supporting publication and product sales.

Yvette Vinci reports that on Friday, August 24, a reminder emailing was sent to members with a summary of "What's trending" in September *QST*—taking advantage of some early analytics shared by Michelle Patnode. The notification was sent to 118.037 members.

Yvette Vinci, John Proctor, and Bob Inderbitzen completed an analysis of 12-months of shipping for direct sales. The effort supports a 2018 goal to study shipping-and-handling fees and expenses, and to make improvements for the same.

REPORT FOR WEEK ENDING SEPTEMBER 1:

Jackie Ferreira reports that August product sales were \$222,674, exceeding the sales forecast of \$185,863 by \$36,811. Year-to-date sales are \$1,799,486 -- \$74,719 short of forecast. Royalties earned on sales of our Kindle e-books were \$6,969; \$7,500 forecast (\$56,471 YTD; \$60,500 forecast). We enjoyed significantly stronger than predicted sales of ARRL License Manuals in August. Direct sales were \$103,098 (\$95,277 in August 2017); dealer sales were \$119,576 (\$100,001 in August 2017).

Yvette Vinci reports that our team of Member Service Representatives handled 3,052 calls in August, versus 3,162 in August 2017. The team includes Margie Bourgoin, Jon Faasen, Liz Karpiej, Kim McNeill, and Cathy Stepina.

Jackie has coordinated the upcoming introduction of the fall ARRL Publications & Products Catalog into the digital edition of October *QST*. Thanks to Jodi Morin and Di Szlachetka for their production and design contributions with updating and readying the catalog for its first-ever debut in digital *QST*.

An email promoting two HF digital books contributed 251 orders over the Labor Day holiday weekend. There were 533 orders total.

Bob Inderbitzen attended the Pennsylvania State Convention, Uniontown GABFEST, on Saturday, Sep. 1 – meeting and greeting attendees, organizers, and Field Organization volunteers. He also gave a presentation highlighting ways to encourage all hams to get active, involved, and on the air. The convention was also attended by Atlantic Division Director Tom Abernethy and WPA Section Manager Joe Shupienis.

Following analysis of our small package shipping for sales orders, Bob has introduced some rate-shopping programming scripts within the warehouse shipping software to help improve the assignment of shipping carriers and delivery methods. Yvette Vinci and Steve Capodicasa are closing monitoring the impact of the change, to ensure we continue to meet delivery expectations. So far, so good! In just the first 24 hours, rate-shopping each order on-the-fly reduced shipping costs by hundreds of dollars.
