### Lab Reported by Joe Carcia, NJ1Q

## WIAW

On Wednesday, February 12, Joe Carcia, Bob Allison, WB1GCM, and Paul Cianciolo, W1VLF, visited the Talcott Mountain Science Center (<u>https://www.tmsc.org/</u>) in Avon, Connecticut to scope out the area in preparation of an installation of an AREDN system. They met with TMSC Board Trustee Don Wilson, K1IN, and TMSC Astronomy/Robotics teacher Mark Meredith, K1MGM.

After a tour of W1TMS – the TMSC radio club station – the area was surveyed to determine the best possible location of an AREDN 5-GHz unit. Some technical details will need to be ironed out before an AREDN system can be implemented at Talcott Mountain.

In addition to testing the smoke/fire alarms at HQ/W1AW, the alarm company Sonitrol also found a phantom "burglary loop" in the W1AW alarm system. This phantom loop was listed as a "garage door" even though no garage door exists at W1AW. This loop was haphazardly tripping, signaling to Sonitrol that there was an apparent "burglary attempt" at the station, even though none existed. It's uncertain how this loop could have been added to the alarm system. Nevertheless, the phantom loop has been removed from the W1AW alarm system.

Joe processed three Qualifying Run certificates and two endorsements. He also created the texts for the week's W1AW Qualifying Runs.

Joe updated the web code practice files and their archives. He also processed regular QSL card requests.

Scot Gee, WB9RRU, worked on fast and slow code practice runs for the week. He also processed eleven electronic VUCC applications for a total of 678 credits.
