Chief Executive Office

On November 14, the ARRL Board of Directors held a special meeting to discuss the report of the Ethics and Elections Committee regarding Director Richard Norton, N6AA.

Communications

Communications met with representatives from nearly all the departments in ARRL HQ to discuss plans for creating a unified 2018 Social Media Content Calendar for the organization. We brainstormed about ideas for our social media platforms and will now be setting up individual meetings with each department to help them with content creation and scheduling.

We posted stories on the web and over social media to solicit nominations for the 2017 Bill Leonard Award, which honors print, radio and television reporters for stories that informed people about the values of amateur radio. The deadline for nominations is December 1.

We also tweaked the Media Hits web page (<u>http://www.arrl.org/media-hits</u>) to make the links to stories about the Amateur Radio community more visible.

To consolidate ARRL's social media footprint, we deactivated two of our Twitter accounts -- @ARRL_PR and @ARRL_NPOTA. We encouraged followers of those accounts to follow our main Twitter account (@ARRL). This move brings the number of Twitter accounts we maintain from five to three, which is much manageable and impactful.

The department also monitored and evaluated social media fallout from the decision by the ARRL Executive Board to censure the Southwest Division Director for violating the Board's Code of Conduct.

Sales and Marketing

Our sales campaign for the 2018 *Handbook*, which promoted the new edition with a personalized Call Sign Badge, ended on November 22. Sales for the *Handbook*-with-badge will exceed 4,500 orders. We have more than doubled the number of *Handbooks* ordered during the same period last year.

Jackie Ferreira coordinated two significant sales campaigns during the Thanksgiving holiday and Cyber Monday. These campaigns contributed to 1,382 online orders placed during the 5-day period from Thanksgiving Day through Cyber Monday. Thanks to Michele Patnode and Dave Isgur for extending these campaigns to include our social media outlets; Facebook, Twitter, etc.

Some members of our team helped adjust their holiday schedules to help fulfill the exceptionally high
volume of orders received during the Thanksgiving holiday. Thanks especially to Steve Capodicasa, Kim
McNeill,McNeill,AllyRiedel,andMatthewBrady.

We have enjoyed an uptick in publication orders from international members following announcements of lower shipping prices to non-US destinations. For example, there were 43 orders from Canada in November, vs. 21 in October.

Yvette Vinci reports that on Tuesday, November 21, a reminder emailing was sent to members with a summary of "What's trending" in December *QST*—taking advantage of some early analytics shared by Michelle Patnode. The notification was sent to 117,508 members (120,784 in 2016).

Yvette continues to work with an interdepartmental team on specifications for new software to support the next generation of our membership and development recordkeeping systems.

We have received a commission of \$4,439 from RFinder, earned on new and renewal subscriptions of RFinder made during the third quarter; YTD \$20,703 (\$23,532 for FY 2016). ARRL established an agreement with RFinder, creator of a web and app-based directory of Amateur Radio repeaters, in February 2016 to be our preferred online resource of repeater frequencies. We conducted an email campaign to help promote RFinder just before Thanksgiving.

Ally Riedel continues to help cover administrative tasks for Education Services.
