**Facebook:** ARRL member Eric Knight, KB1EHE, played a role in the development of an RF-based Alzheimer's disease treatment that now shows great promise. A study published today in the Journal of Alzheimer's Disease following a months-long FDA clinical trial of the treatment protocol concluded that memory decline in most patients "appeared to have been reversed to cognitive levels equivalent to 12 months earlier" after 2 months of treatment. The clinical trial concluded last December 31 and focused on the initial efficacy of what NeuroEM Therapeutics, Inc. — the company developing the device — calls "transcranial electromagnetic treatment" (TEMT), using a noninvasive head-worn device called the MemorEMÔ. <u>http://www.arrl.org/news/arrl-member-had-role-in-promising-rf-treatment-device-for-alzheimer-s</u> #ARRL #HamRadio #RF
