Facebook: A social media joke early this summer setting up a "Storm Area 51, they Can't Stop Us All" group now has spiraled into emergency declarations in two Nevada counties and spurred an Amateur Radio Emergency Service (ARES®)/Radio Amateur Civil Emergency Service (RACES) deployment of personnel and equipment. Some predictions say the "Storm Area 51" event will draw thousands — many possibly ill-equipped to be out in the desert environment — to the Nevada Test and Training Range, which contains the US Air Force facility known as Area 51. ARES teams plan to staff and support six incident-specific locations along the 50-mile event corridor known as Extraterrestrial Highway, starting on September 19 and continuing until September 24.
