On Monday and Tuesday, W1AW continued to monitor the various nets that activated for Hurricane Irma. This was performed until the various nets secured operation.

Joe updated the web code practice files and their archives. He cut two additional 40-meter dipole antennas for use with the Ham-Aid kits. Joe upgraded the lighting in the Icom IC-PW1 amplifiers in the broadcast racks. He installed the donated Orban Optimod 9300 audio processor in the broadcast racks as well. Once

he obtains the proper cabling, he'll wire the unit into the audio chain used in the broadcasts. On Tuesday, Joe recorded – with Michelle Patnode behind the camera - a 30-second video for use with the "Tech Tip Tuesday" series. The theme of the video was how to interface your radio to a PC to operate digital modes.

Lori Kosier, N1SMK, ARRL Lab volunteer, will soon assume the responsibilities of processing the remaining 2014 W1AW/xx Centennial QSL card requests that continue to be received at HQ. Joe will be installing QSL printing software for her use, and will train her in the process once the software is properly configured.

Scott worked on fast and slow code practice texts for the upcoming week. He processed one paper, and thirteen electronic VUCC applications, for a total of 686 credits.

Yvette Vinci has completed the Statements of Ownership for our periodicals *QEX* and *NCJ*. She is finishing the statement for *QST*. This reporting is required annually by the US Postal Service.

Materials were assembled and shipped to support the ham radio clubs exhibiting at the World Maker Faire in New York City, Sep 23-24. Bob Inderbitzen, Tom Gallagher, and Director Mike Lisenco will attend the event to support the volunteers. Last year's event attracted 90,000 people.

Yvette helped organize ARRL's exhibit for the upcoming Great Lakes Division Convention in Michigan next month.

Bob Inderbitzen and Yvette have negotiated lower prices for FedEx express shipping to non-U.S. destinations, for packages weighing 5 to 10 lb. Pursuing the lower rates is intended to help increase sales of ARRL publications to international members and customers.
