June ended with 161,118 members -397 members *ahead* of year-to-date goal. A loss of 665 members was forecast for the month; we lost 699 members. Earlier this month, we began testing a new direct mail package to newly licensed hams. Replies have just started coming in; the test will continue for at least 4 months. The on-time renewal rate for June is 71.80% vs. 68.93% last June.

Sales and Marketing

This department report covers two weeks. Jackie Ferreira reports that publication and product sales in June were \$205,278, falling short of the forecast of \$232,971. Despite the shortfall, net sales were only \$3,975 from target. Direct sales were \$131,212; dealer sales were \$74,066. Year-to-date sales are \$1,452,075; \$1,883 ahead of forecast. Royalties earned on sales of our Kindle e-books in June were \$6,404 (\$46,348 year-to-date).

Jackie prepared email solicitations promoting publication and product sales, with "first day of summer" and "getting on the air" themes. She also reports that new postcards have been designed to encourage Technician and General Class licensees to upgrade.

Yvette Vinci reports that on Tuesday, June 20, a reminder emailing was sent to members with a summary of "What's trending" in July *QST*—taking advantage of some early analytics shared by Michelle Patnode. The notification was sent to 117,958 members.

A mid-year operational summary was prepared. Reforecasts were completed following our review of department expense and revenue results vs. plan.

Display and exhibit materials were prepared and shipped for ARRL's exhibit at the upcoming International Exhibition of Radio Amateurs in Friedrichshafen, Germany, July 14-16.

Materials were assembled and shipped to support a significant ham-radio-and-youth outreach effort organized by the Garden School ARC in New York City during Field Day weekend.

Materials were fulfilled for the New England Division Cabinet meeting.
