David worked with ARRL directors and officials on the development of a statement to respond to a reporter asking for comment on the latest activity in Congress involving the reauthorization of the FCC and the Amateur Radio Parity Act. David provided the statement to the reporter for TRDaily.com, an online newsletter following the telecommunications industry. David established the reporter as a contact that we can pitch future stories to.

Work continued on a wide variety of issues surrounding messaging for the new ARES Connect volunteer management system. Those issues range from editing the ARES Guidelines to copyrighting the content of training webinars.

In preparation for Hamvention, David and Michelle attended a demonstration of an app that could help manage the logistics of the event – from the event's schedule and a map of the exhibition hall to messaging and photo-sharing. Michelle and David also met with Bob Inderbitzen and Steve Ford to go over plans for news and social media coverage of the gathering.

Michelle took photos of the Fairlawn (NJ) Amateur Radio Club touring ARRL HQ, and then worked with Sue Fagan to create new displays for the video monitor in the ARRL HQ lobby.

Bob Inderbitzen worked with US Bank and General Counsel Chris Imlay to finalize amendments made by the bank to the agreement for the ARRL Visa Credit Card Program. ARRL earned program royalties of \$43,692 in 2017.

Bob finalized some additional planning for ARRL's exhibit at the International Amateur Radio Exhibition in Germany, which will be held June 1-3 this year. He also assembled a list of ARRL-sponsored presentations for Hamvention (May 18-20).

Bob met with Michelle Patnode, David Isgur, and Steve Ford to review objectives for news, editorial, and related content creation at Hamvention. This group also, with Barry Shelly, participated in a demonstration of a mobile app platform for events.

An online survey to support 2019 *Handbook* planning is underway. It was distributed to a selection of individuals from two groups: most recent edition (2018) purchasers, and ARRL members.

Bob and Yvette Vinci participated in a meeting with other staff (Mailroom, IT, and Membership) to review our application of national change-of-address processing on ARRL mail lists and recordkeeping.
