## <u>Lab</u>

From Newington, Zak Lau, W1VT, reports that an Australian amateur told him that the Match program was missing from the 2020 ARRL Handbook Download. Zak forwarded this information to Ward Silver, N0AX, the lead book editor, who quickly uploaded the program to: <u>arrl.org/arrl-handbook-reference.</u> Zak also reports that it is impossible to email programs, such as the Match program, via Gmail, due to security concerns. Zak manages the Technical Information Service, maintains many of the "ARRL Technology" web pages, and monitors our web site forums on a continual basis.



From Harwinton, Paul Cianciolo, W1VLF, reports business as usual, with many RFI inquiries. As promised, here's another photo of Paul's latest antenna construction project:

That's Paul in the center, yellow shirt. Out of shot in the photo was a very large crane, used to hoist Paul's array to the top of his 120-foot tower. Good job, Paul! (Nice signal on the air!)

Bob Allison reports from the ARRL Laboratory that he completed testing of a legal-limit, solid state, power amplifier. Data was compiled, charts made, and all passed along to Mark Wilson. The amplifier and other items will be photographed by RJS Photography before being delivered to the reviewer, who lives a couple of towns over from Bob in Eastern Connecticut. Next, Bob started retesting of a high-performance HF transceiver. Initial

testing indicated a possible roofing filter issue in the sub-receiver, since Intermodulation Distortion of the third kind was slightly higher than the main receiver; the receivers should be identical in performance. The filter was replaced by the manufacturer and the transceiver shipped back to the lab. The manufacturer was quite happy.

#### W1AW

Joe Carcia created the texts for the week's W1AW Qualifying Runs and processed six Qualifying Run certificate and four endorsements.

Joe updated firmware on a Flex Power Genius XL amplifier for Product Review. Joe also began to work with AREDN's Randy Smith, WU2S, to enable the Tunnel Server on one of the W1AW AREDN nodes.

Scott Gee, WB9RRU, worked on slow and fast code practice run files for the week. He also processed eight paper and thirty-nine electronic VUCC applications for a total of 2631 credits.

## **Product Development**

In June, we began to rollout a new initiative and membership benefit named the <u>ARRL Learning Network</u> (beta) by seeking help from Section Managers to help identify prospective speakers for a series of online webinars presented by member-volunteers, for members (see <u>Call for Speakers</u>). That effort secured our first 7 webinars for July and August, the first completed on July 28 with a presentation Aaron Hulett, K8AMH, the Section Traffic Manager for the ARRL North Texas Section. Presentations are a short 30minutes each, intended to attract members participating during lunch breaks or as a short evening activity. We are using ARRL's 500-seat GoToWebinar account to serve the live presentations, Doodle for self-scheduling of presenters, and a newly created PowerPoint template for presentation slides. The ARRL Learning

This meeting focused on the development of accompanying instructions for constructing the kit, and a companion curriculum. The meeting included staff members Paul Cianciolo for the Lab, Kris Bickell for Lifelong Learning, and Bob Inderbitzen for Product Development.

Bob participated in a handful of Zoom meetings including a monthly business unit update, the Management Council, and Personify.
