Chief Executive Office

Following two full weeks of departmental 2021 budget plan meetings, David Minster, NA2AA, and Diane Middleton, W2DLM, joined by Controller Tom Bell, held budget plan overview meetings. David and Diane also held regular monthly departmental meetings with Lifelong Learning and Product Development. David continues to receive daily Personify updates, as well as take many meetings with managers across departments as he continues to assess ARRL's initiatives and operations.

The Executive Committee held it's fall meeting via Zoom last Thursday, October 22, with many non-committee members of ODV joining in as observers. The minutes will be posted publicly once they have been reviewed and approved by the full committee. The Committee decided that the ARRL 2021 Annual Board Meeting will be fully virtual, held via Zoom over a two-day period.

The Programs & Services Committee also met last week via teleconference on October 21. Minutes will be shared with the full Board once they have been reviewed and approved. The Committee increased their meeting schedule earlier this year to meet on a monthly basis.

The Technical Awards page was updated to include the Doug DeMaw, W1FB, Technical Excellence Award. Steve Ewald, WV1X, Dan Henderson, N1ND, and Carla Pereira worked together to write, edit and post the content.

David Minster has asked Dee Methe, KC1MHN, to begin working on a comprehensive corporate calendar for the League. Intended to be used as a planning tool, it will include relevant information from all departments.

Carla continues to send replacement ballots to the handful of members who reported not receiving the Division election ballots that were mailed on September 30 to the Dakota, Great Lakes and Midwest Divisions. The requests have been fewer than anticipated, which is good news.

Leona Adams, W1LGA, reports that she been working with ARRL members in the New York City-Long Island Section to send out second ballots to those who reported that they did not receive the ballots that were first sent at the end of September. Section Manager election ballots are due to be received no later than Friday, November 20, and the ballots will be counted on Tuesday, November 24.

Leona continues to provide administrative support for new Section Managers who have started terms in recent weeks and newly-appointed Field Organization members.

Mississippi Section Manager Malcolm Keown, W5XX, and Wyoming Section Manager Rick Breininger, N1TEK, have been nominated to run for new terms of office in their respective sections. Nominations for this particular section election cycle need to arrive at Headquarters by December 4, and the new terms of office begin on April 1, 2021.

W1AW

Joe Carcia processed two Qualifying Run certificates and four endorsements. He also updated the web code practice files and their archives.

Joe constructed the new M-Square 2 meter, 70, and 23 centimeter Satellite antennas for replacement scheduled the week of October 26. He also configured the new Yaesu G5500 Azimuth/Elevation rotators, also slated for replacement.

Joe worked the Monday, Tuesday, and Friday late afternoon/night shifts for the vacationing Scott Gee, WB9RRU. He also met with a Cox CATV technician to determine what steps to take to get CATV access to W1AW. W1AW had CATV access some years back. However, changes to the CATV frequencies caused this access to be limited, if not discontinued altogether, given how the CATV signal is delivered to W1AW (via cable running inside conduit buried underground and reaching across the parking lot to HQ).

Scott Gee processed eighteen electronic VUCC applications for a total of 1660 credits. He also worked on fast and slow code practice files for the week.
