Leona Adams, W1LGA, reports that New York City/Long Island will be the only Section Manager balloted election held this fall after the nomination receipt deadline arrived on September 4th. Donnie Katzovicz, W2BRU, of Brooklyn, is running against incumbent Section Manager Jim Mezey, W2KFV.

Michael Douglas, W4MDD, of Wauchula, Florida, an Assistant Section Manager, will become the new Section Manager of West Central Florida starting January 1, 2021. Michael was the only nominee after Section Manager Darrell Davis, KT4WX, decided to withdraw his nomination to run for a new term of office. Darrell has been Section Manager for three terms of office (six years).

W1AW

Joe Carcia created the texts for the week's W1AW Qualifying Run transmissions. He also processed two Qualifying Run certificates and one endorsement.

The webinars are managed as a Lifelong Learning program. The initiative was introduced in July, and the first 8 webinars have enjoyed live attendance and views from over 4,000 members.
