Field Services

Steve Ewald, Wv1X

Kevin O'Dell, NOIRW, Oklahoma's long-serving Section Manager — serving two terms from 2010 to 2014 and again serving since 2016 — has decided to step down effective April 9, 2021. Although stepping down as OK SM, O'Dell will continue to serve Amateur Radio and the ARRL as a member of the ARRL's Public Relations Committee.

Mark P. Kleine, N5HZR, a resident of Norman, OK has been appointed to replace O'Dell as Oklahoma Section Manager, effective April 9, and will serve out the balance of O'Dell's term that extends to September 30, 2022. Prior to becoming SM, O'Dell served as both a Public Information Officer and as the Public Information Coordinator for the Oklahoma Section for many years. Kleine has also been a very active member of the Oklahoma Amateur Radio Community for many years, currently serving as an OK Assistant Section Manager, a leader of the South Canadian Amateur Radio Society (SCARS) and as President of the Central Oklahoma Radio Amateurs (CORA), a group of nine Amateur Radio clubs that host the Oklahoma City hamfest Ham Holiday. An ARRL Life Member, Kleine is also an amateur radio license class instructor and Volunteer Examiner for three different Volunteer Examiner Coordinators.

ARRL Radiosport and Field Services Manager Bart Jahnke, W9JJ, made the appointment based on the recommendations of ARRL West Gulf Division Director John Robert Stratton, N5AUS, O'Dell, N0IRW,

West Gulf Vice Director Lee Cooper, W5LHC, and leaders of the Oklahoma Section. Leona Adams, W1LGA, and Steve Ewald have been working with Mark, N5HZR, and Kevin, N0IRW, during this Section Manager transition.

Leona received and processed a petition that nominates Jim Millsap, K9APD, of Acworth, Georgia, to be a candidate to run for the office of Georgia Section Manager. The next term of office begins on October 1, and nominating petitions are due at Headquarters by June 4.

Lab

Bob Allison, WB1GCM

The ARRL Lab staff continues to handle incoming email and telephone inquiries from ARRL members. Paul Cianciolo, W1VLF, reports that many of his emails and phone calls are from members who are having trouble with either their own solar power installation, or from a neighbor's solar power installation. It is to be noted that Paul is preparing a presentation regarding the RFI that can be generated by certain solar power installations. Paul routinely handles such RFI cases and works with solar power companies to mitigate interference experienced by our members. Paul also receives inquiries regarding RFI from Grow Lights and faulty hardware on utility poles (Power Line Noise).

Ed Hare, W1RFI, has been working on a number of EMC (Electro-magnetic Committee) issues, including the reporting of VHF/UHF handheld transceivers which do not comply with a number of FCC rules, as well as wireless power transfer.

Bob Allison is very pleased to report that a major manufacturer of Amateur Radio Transceivers has followed the advice of the ARRL Lab by eliminating both 1 and 2 ms (mil-second) shaping menu options. Shaping is determined by the rise and fall time of a CW waveform; if these times are too fast, a wider than desired CW bandwidth occurs, which causes interference to other operators adjacent to such a signal. Importantly, Bob noted the rise and fall times were actually faster than the menu suggested, so Bob advised the manufacturer to change the factory default setting from 4 ms, to 6 ms. A full technical explanation will be included in "QST In Depth", showing spectral plots of CW bandwidth versus rise/fall time. But wait--there's more! It is exceptionally good news that this same company will eliminate the 1 and 2 ms shaping options and change the default setting with their flagship, top performing HF/6-meter transceivers. The manufacturer thanked the ARRL Laboratory and QST Product Review Editor, Mark Wilson, K1RO, for their help.

Bob Allison has announced that he will be retiring on Friday, April 9. Bob wishes to thank everyone at HQ for his opportunity to help ARRL members over the past 13 years. Bob's deep expertise and enthusiasm for amateur radio and radio communications will be greatly missed at HQ and by members. We wish Bob all the best in his next phase!
