The 2018 ARRL Director and Vice Director elections officially began last week with the publication of the election announcement in July's *QST*. Election packets have been sent to all who have requested them to date. Eligible members have until August 10 to request nomination forms, and the deadline for receipt of the completed forms is August 17. This year's elections are being held in the following divisions: **Central, Hudson, New England, Northwestern, and Roanoke.** 

Planning and preparations continue for the 2018 July Board meeting.

## **Communications**

David reached out to Field Day site operators to begin making plans to visit sites in the New England region on Saturday, June 23. Plans are being finalized to visit Blackstone Valley Amateur Radio Club in Rhode Island, Eastern Connecticut Amateur Radio Club in Pomfret, CT, and Hampden County Radio Association in Agawam, MA. In addition, David continued to provide information to PIOs about reaching out to the media and the general public through press releases and social media messaging. He responded to a number of direct requests/questions from field operatives.

Michelle Patnode sent out a note about tips for effectively using social media to promote Field Day to PIOs via the PR reflector. The note was shared by Andy Miluzzi on the ARRL Collegiate Amateur Radio Facebook group, and will be published in the Kansas Amateur Radio Newsletter thanks to Kent, KB0RWI. Michelle also posted updates to the Social Media section of the Field Day web page.

David was asked to participate in ARRL's 2018 Atlantic Hurricane Season Preparedness webinar, which was organized by Mike Corey, on June 11. He and Michelle worked on a PowerPoint presentation to outline the role that ARRL's Media Relations team can play in helping to highlight Amateur Radio's role in disaster response efforts. Michelle is also working with Mike Corey on ARES Connect training videos.

Michelle used our social media platforms to publicize the news that the FCC was imposing a \$2.8 million fine on Hobby King, Inc. for selling a drone with a radio-controlled transmitter that violates FCC regulations. This was an issue that had been brought to the FCC attention by the ARRL's Electro-Magnetic Compatibility Committee, with supporting test results from the ARRL Lab.

We've decided to delete the ARRL's Snapchat account, effective June 29, due to the lack of value that Snapchat offers ARRL as a social media. We receive more engagement on the Instagram story feature which is similar to Snapchat. The Instagram stories are now linked to Facebook stories, so Facebook followers can view the content there, and possibly follow our Instagram page. Michelle created messages to encourage Snapchat followers to follow us on our other social media platforms instead.

Michelle updated the ARRL HQ Lobby PowerPoint with four new slides from Sue Fagan. Michelle will be posting the 5<sup>th</sup> slide with our updated list of social media platforms once we delete Snapchat on June 29<sup>th</sup>.

David led the monthly meeting of the ARRL Public Relations Committee at which the Committee voted to make a recommendation to the ARRL Board of Directors for the 2018 Philip McGan Silver Antenna Award that recognizes volunteer excellence in public relations.

## Top Social Media Posts

#### Facebook:

In the wake of an investigation resulting from a 2017 ARRL complaint, the FCC has proposed fining HobbyKing and associated entities \$2.8 million for apparently marketing noncompliant RF devices and failing to comply with Commission orders. According to a June 5 FCC Notice of Apparent Liability (NAL), HobbyKing appears to have sold audio/video transmitters (A/V) intended for use with unmanned aircraft, such as drones, marketing them as Amateur Radio equipment in some instances. "The Enforcement Bureau previously issued a Citation notifying HobbyKing of its legal and regulatory obligations and ordering it to cease and desist from marketing noncompliant equipment," the FCC said in the NAL. "Additionally, the Bureau issued a Citation against HobbyKing for failing to fully respond to a Letter of Inquiry. Despite these Citations, HobbyKing has continued its apparently unlawful practices."

HobbyKing had denied that it was marketing its drone transmitters to US customers, but ARRL's January 2017 complaint pointed out that ARRL Laboratory Manager Ed Hare, W1RFI, was able to purchase two drone transmitters from HobbyKing and have them shipped to a US address for testing in the Lab. <u>http://www.arrl.org/news/arrl-drone-transmitters-complaint-spurs-proposed-2-8-million-fcc-penalty</u>

## **Field Services**

Friday, June 8, was the receipt deadline for nominating petitions for the summer season Section Manager election cycle. There will be two elections this summer: Dave Heintzleman, ND0CW, of Newburg, North Dakota, is running against incumbent North Dakota Section Manager Nancy Yoshida, KG0YL, of Thompson; in Western New York, Elliott Blauvelt, Jr., N2OJM, of Horseheads, is running against incumbent Western New York Section Manager Laura Mueller, N2LJM, of Falconer. Leona Adams has been in touch with all candidates to begin preparations for the elections.

In Eastern Pennsylvania, current Section Manager Bob Wiseman, WB3W, decided not to run for a new term of office that officially began on April 1. Since no nominations were submitted by December 8, 2017, a re-solicitation of nominations took place this past spring. Bob, WB3W, is graciously continuing to serve as SM for an extra six months until September 30. George Miller, W3GWM, of Wyalusing, will become the new Section Manager of Eastern Pennsylvania starting October 1 for an 18-month term. George became the only nominee after Duane Reese, N6DMR, decided to withdraw his nomination.

In Southern Florida, current Section Manager Jeff Beals, WA4AW, decided not to run for a new term of office that begins on October 1. Barry Porter, KB1PA, of Delray, will become the new Section Manager in Southern Florida as he was the only nominee.

The following incumbent Section Managers will begin new two-year terms of office on October 1 as they were the only nominees in their respective sections: Chuck Motes, K1DFS (Connecticut); Skip Jackson, KS0J (Minnesota); Scott Yonally, N8SY (Ohio); Kevin O'Dell, N0IRW (Oklahoma); Oscar Resto, KP4RF (Puerto Rico); Fred Kleber, K9VV (Virgin Islands).

Idaho Section Manager Ed Stuckey, AI7H, decided not to run for a new term of office after serving in this position since 2008. Since there were no nominations, the Idaho Section Manager position will be resolicited starting in the October QST.
