In essence, W1AW is NOT within 1 kilometer of a transmission line that conducts a power line carrier (PLC) signal in the 135.7 to 137.8 or 472.0 to 479.0 kHz frequency range.

Sales and Marketing

This department report covers two weeks; Oct 9-22:

It has been all hands on deck as we continue to assemble and ship orders for the 2018 *ARRL Handbook*. Our team of Membership Service Representatives has been busy printing and matching packing slips with personalized member badges for the advance orders; thanks to Margie Bourgoin, Kim McNeill, Ally Riedel, Cathy Stepina, and supervisor Yvette Vinci. Our warehouse clerks have been packaging the shipments; thanks to Michael Scharr, Matthew Brady, Alan Gosselin, and supervisor Steve Capodicasa. Bob Inderbitzen produced a <u>Facebook LIVE broadcast</u> from our warehouse, highlighting the work being completed to ship advance orders for the *Handbook*. Thanks to Michael Patnode and the warehouse staff for their assistance with the video shoot.

Yvette prepared the bulk email notification for the November 2017 digital edition of *QST*, distributed to ARRL members on Friday, October 6. The distribution list included 116,221 members. Yvette also prepared a reminder, emailed to members on October 17, with a summary of "What's trending" in November *QST*—taking advantage of some early analytics shared by Allison McLellan. Approximately 8,000 members are considered digital-QST-only subscribers. These are domestic members who have voluntarily opted-out of print *QST*, or international members who have selected the digital-only membership rate. There was very little change in the total number of digital-only members as compared to last year.

Yvette prepared a report for the recent Executive Committee Meeting with a listing of the elected Life Members since the last EC meeting—302 new Life Members. She reports that in October we processed 92 paid-in-full Life Memberships and 25 new Life Membership pledges.

The cover for the 2018 ARRL Repeater Directory has been completed. The new edition will begin shipping Jan 1, 2018.

Bob Inderbitzen finalized a group sales agreement to return to the Marriott at the University of Dayton with our usual large team of staff, officials, and volunteers supporting ARRL's exhibit at Hamvention. 2018 Hamvention is May 18-20.

Bob participated in a luncheon organized by Diane Petrilli to thank and recognize our volunteers supporting the ARRL Headquarters Volunteer and Tour Guide Program. Bob also made a presentation at the Section Managers' Workshop, highlighting our publications and resources for promoting ARRL membership at events.

Jackie Ferreira produced a bulk email to promote the new <u>2018 ARRL Calendar</u>. She also finalized mailing plans for a handful of projects that will support our direct sales goals throughout the fourth quarter.

We organized the ARRL exhibit for Pacificon, the Pacific Division Convention, held in San Ramon, California, October 20-22. Carla Pereira and Bob Inderbitzen traveled as staff representatives. The annual event is among the largest ham radio conventions, and included workshops, forums, VE testing, kit building, youth activities, and club exhibits. There were two exhibit halls covering all of the major ham radio manufacturers and resellers. Director Bob Vallio, Vice Director Jim Tiemstra, and most of the Pacific Division Section Managers were on hand to support ARRL's participation at the event. The Saturday evening banquet included a keynote address from President Rick Roderick. Rick's wife Holly was a tremendous help in the booth, too. There were opportunities for attendees to get on the air from the special event station, W1AW/6, organized by the Palo Alto Amateur Radio Association. Bob and Carla returned from Pacificon with 139 membership applications, including 21 new members. Dues and subscriptions collected at the convention totaled \$9,032. Bob and Carla documented the event, posting photos and videos to the <u>ARRL Facebook page</u>.
