


The chart below shows the license class among current members: 43% of all members are Extra class licensees, followed by Generals at 26%.



Yvette Vinci reports that members of the warehouse and fulfillment groups supported the annual physical inventory on Monday, January 4. The auditor gave the warehouse a thumbs-up. This is the fifth consecutive year of perfect counts. Due to the swift and good work of everyone involved, we were able to resume shipping orders just after noon-time on Tuesday, January 5.

Yvette also reports that our team of Member Service Representatives handled 3,330 calls in December (vs. 3,366 in December 2019). The team includes Margie Bourgoin, KB1DCO, Jon Faasen, AA1EZ, Liz Karpiej, KA1DTU, Kim McNeill, KM1IPA, and Cathy Stepina. The support calls included helping customers place orders, renew memberships, check on order status, help with magazines app, call transfers, etc.

Steve Capodicasa, ARRL Warehouse Supervisor, reports that December was a very busy month. The warehouse processed 1,308 packages on the last four shipping days of 2020. He also reports that his team processed 66,298 packages for individual and dealer orders in 2020 (vs. 48,784 in 2019).

## **Product Development**

## Week Ending January 24

In the days following the demonstrations and violence at the Capitol, members shared our concern about instances in the media cycle and in online chatter suggesting radios were/could-be/are misused. ARRL published a message intended as a counterbalance -- by rightfully claiming our role as good stewards of radio communication and radio technology, and by recognizing our proud history of public service. The message was quicky picked up by web searches, assuring us that anyone who needed to hear some or all of our message will know that ARRL publicly condemns the misuse of amateur radio frequencies. Following publication of our message and the FCC's Advisory, Bob Inderbitzen handled direct media inquiries and those referred to him by members, using the opportunity to inform and educate reporters about the basis and purpose of our hobby and service. He also responded to many messages and phone calls from members and Field Organization volunteers. He turned around some members who initially reacted by promising to cancel their membership, one replying to Bob by writing, "I have to admit that I'm surprised and flattered that you took the time to respond. Please know that it is appreciated. … In fairness, I may now renew my membership."

Bob produced a 4-minute video about the ARRL QSL Bureau featuring Rose-Anne Lawrence, KB1DMW, and with help from Bart Jahnke, W9JJ. Initially intended to be viewed during a club presentation made by Bart, the video has now been posted to ARRL's YouTube channel: <u>https://youtu.be/Vxgcn3sMVtU</u>. Special thanks to Rose-Anne for her willingness to help us create a video tour of the QSL Bureau that everyone can enjoy. The video was recorded and edited entirely on Bob's iPhone 12 Pro in Dolby Vision 4K.

Bob also completed editing for the instruction sheet that will accompany ARRL's Intro to Radio Receiver Kit.

## Week Ending January 17

The Chairman of Dayton Hamvention, Rick Allnutt, WS8G, made a personal call to us with news of their decision to cancel 2021 Hamvention. We've helped share their announcement via ARRL News and social media outlets. Similarly, SEA-PAC canceled their June convention held in Seaside, Oregon.

Bob Inderbitzen participated in several meetings including the monthly Public Relations Committee meeting, Management Council, and a discussion with Kathleen Callahan, KC1MBY about developing a pool of ARRL presenters for club meetings and hamfests.
