David Isgur was involved in follow-up work from the January 18-19 Board of Directors Annual Meeting. David drafted a statement for the Board on its position regarding the Amateur Radio Parity Act and the resolution that was adopted at the meeting to withdraw (without prejudice to refiling) its petition to the FCC regarding the ARPA.

David also worked on other news articles to highlight ARRL projects that were approved by the Board.

There was a presentation of our "Social Media Guide" at the Board meeting, which included a request that Directors and Vice Directors review the ARRL Social Media page on the website (http://www.arrl.org/arrl-social-media) to make sure that their region's social media accounts are accurately featured. Development

The ARRL Foundation's Annual Meeting was held on January 29,2019. New ARRL Foundation Board members, elected by the ARRL Board of Directors at the January 18-19, 2019 Annual Meeting, include Atlantic Division Director Tom Abernethy, W3TOM, for a three-year term, Northwestern Division Director Mike Ritz, W7VO, for a two-year term, Pacific Division Director Jim Tiemstra, K6JAT for a one-year term, and Southwestern Division Director Richard Norton, N6AA, for a three-year term. West Gulf Division Director Dr. David Woolweaver, K5RAV, resigned from the ARRL Board, but was elected to remain on the ARRL Foundation Board for another three-year term. Also elected to serve on the ARRL Foundation Board are Tim Duffy, K3LR. Jim Fenstermaker, K9JF, Brian Mileshosky, N5ZGT, and Mr. Norris, K5UZ, remain on the ARRL Foundation Board to complete their terms. During the ARRL Foundation Annual Meeting, Dr. Woolweaver was elected President, and Mr. Mileshosky was elected Vice President. Rick Niswander, K7GM, was re-elected as Treasurer and Lauren Clarke, KB1YDD, was re-elected as Secretary.

Dr. Woolweaver appointed Mr. Fenstermaker to serve as the Scholarship Committee Chair, with Mr. Abernethy, Mr. Duffy, Mr. Norris, Mr. Ritz and Mr. Tiemstra also serving. Dr. Woolweaver appointed Mr. Mileshosky to once again serve as the Proposals Committee Chair, with Mr. Norton and Dr. Woolweaver also serving. Dr. Woolweaver will serve on the Audit and Financial Committee Chair with Mr. Mileshosky and Mr. Niswander.

The Foundation Board also unanimously approved Bob Heil, K9EID, as the recipient of the 2018 Bill Orr, W6SAI, Technical Writing Award for his January 2018 *QST* article "The Pine Board Project" as recommended by the *QST* Editorial staff.

ARRL received a \$50,000 gift through the Thomas L. and Wylda Hammond Nelson Revocable Trust. Mr. Nelson held the call sign W6EO.

The ARRL Foundation received \$46,683 on January 9, 2019 through the estate of John Donald, W7OIQ. The Foundation is also named as a beneficiary of Mr. Donald's Trust and his Edward Jones account.

Lauren was notified that ARRL will receive \$2,000 from the estate of Arnold M. Bucksbaum, WØWGZ.

Lauren completed the Combined Federal Campaign application for consideration by the Office of Personnel Management so that ARRL may be listed as an eligible organization in the 2019 CFC Campaign.
