# **Membership**

July ended with 155,909 members, a 479 member loss over last month (a loss of 669 members was forecast). We are behind year-to-date goal by 329 members. The on-time renewal rate for July expirees was 73%, the same as last July.

Diane Petrilli attended several hours of meetings with Personify, ARRL's new AMS vendor, from July 22-25. This first "sprint" involved setting up Constituents and Committees.

Diane also attended a Mintz + Hoke "mood board" meeting July 11, to further refine the look and feel of the new LLL platform.

Diane prepared a membership report for the July Board Meeting. She also completed a draft budget for membership for 2020.

### **Product Development**

The Management Council has approved a new publication being advanced by Steve Ford, WB8IMY, and the publication planning team. "Microcontroller Projects for Amateur Radio" will be authored by Jack Purdum, W8TEE, and Al Peter, AC8GY, and will be published in late 2020.

Bob Inderbitzen returned from supporting ARRL's exhibit at EAA AirVenture in Oshkosh, Wisconsin. This was our second year organizing an exhibit for the world's largest air show and aviation celebration, originally suggested by Director Kermit Carlson, W9XA. Bob organized an all-volunteer team of member-volunteers to help operate our booth, including Wisconsin Section Manager Patrick Moretti, KA1RB and other Field Organization volunteers and ham-pilots. There were also 2 special event stations on the grounds. The event draws a half million people – mostly pilots and aviation enthusiasts. Our efforts identified hundreds of pilot-hams and prospective hams. The effort contributes to a strategic objective to increase interest in Amateur Radio from among groups with likeminded interests. The exhibit has increased the visibility of Amateur Radio and ARRL among the aviation community. The event included

national representatives and exhibits from Icom (a major sponsor) and Yaesu. An EAA Board member organized radio construction project-building activity for youngsters attending the show (thousands). The crystal radio project was designed by a 21-year old RF engineer (his dad and sister are hams). ARRL has been invited to explore sponsorship role for 2020. organizations exhibiting at the event included the National Park Service, all of the military branches, AARP, and many colleges and universities. It was a superb outreach effort.

As reported earlier this year, ARRL was approached by the Civil Air Patrol with their interest in establishing a framework for ARRL-affiliated radio clubs throughout their national structure – as many as 61 radio clubs. The CAP's primary interest in establishing these radio clubs is to offer Amateur Radio licensing classes to CAP Cadets – youth members of ages 12-18. CAP already includes a nation-wide radio communication program and system with HF, fixed-land, and mobile radio capability deployed with CAP units in every state. By offering Amateur Radio license instruction courses, the CAP intends to increase the radio communication skill level and training of their Cadets. The classes will use ARRL instruction materials and resources. ARRL has a 2005 Memorandum of Agreement with CAP providing a broad framework of agreement between our two organizations. At their urging, a revised MOA is being prepared to help support this new initiative.
